- To enter submit four (4) 4 X 6 unframed color photos of the exterior with a completed entry form. Interior pictures are optional. *No polaroid pictures please.*
- Entries must be postmarked by September 1, 2010 to be eligible. Winners will be notified by December 1, 2010.
- The home depicted in the photos must be located in the state of North Dakota.
- Photos with no entry form, or with an incomplete entry form, will be disqualified from the contest.
- Decisions of the judges are final.
- All federal, state and local taxes are the sole responsibility of contest winners.
- All fees and personal expenses incident to contest entry and the redemption of prizes will be the sole responsibility of contest winners.
- Your signature on the entry form indicates you agree in writing that your photos become the property of NDMHA and authorizes the Association to use such photos for modular and manufactured housing promotional and publication purposes. Failure to sign will disqualify your

submission in the contest and cause forfeiture of any potential prizes.
